We all know the story: "Gone to Katy." Many of the single-family homes in our area are now, practically speaking, multifamily dwellings. Just count the cars parked in the driveway and on the curb in front of so many homes. Many homes that were privately owned, are now rental property. Some of these property owners are responsible people who work to monitor their renters and to maintain their properties. Sadly, many do not make this effort, and we all suffer.

Commercial interests are moving into our neighborhood, which bring blight to our area and we are helpless to stop or to control them. And the list goes on. Maybe the thought of urban blight is something you would rather not consider. Some of our neighbors have already considered these challenges and have opted to sell their homes and move to other. newer neighborhoods. However, many were shocked to find that relocation did not help them escape this problem. When they put their homes on the market, they found that the value they had assumed for their home was in fact not realistic. One friend, who decided to move, finally sold his home for \$30,000 less than the appraised value on which he had been paying taxes. I call that "the high cost of education."

I share this information as background to tell you that many in this area made a decision to do something besides complain. We banded together and we organized. We organized the homeowners associations, in the Mission Bend and Clayton area. We formed a council of 13 homeowners associations, which collectively represent around 25,000 people. We called this organization the Greater Mission Bend Area Council. Our efforts drew media attention and we were featured in several stories in the Houston Chronicle. And Channel 13 took notice of our work and did a special, which shared our story with the entire city.

And public officials took notice of our efforts. Recently we had the county judges from both Harris County and Fort Bend County come and speak to our members. Ed Emmett and Bob Hebert were impressed enough with our efforts to take time from their busy schedules and come and sit down and talk with us. Imagine having these two county judges in the same room at the same time, listening to our concerns and offering their advice to us. Priceless, as the commercial says. But we didn't stop there. State Senator Joan Huffman also came and met with us. In January, we plan to have the sheriffs from both counties meet with us. Stay tuned. We'll offer that as a public meeting and encourage all our

citizens to attend.

We are a fledgling organization and we still have a long way to go to meet any of the challenges which our community faces. But we are off to a good start. We have strong support in the community for our work. The coming year will be very important for our efforts as we begin to develop an action plan to confront the problems of our aging community. Real Estate Market Report

With a great deal of fine tuning of the search criteria in MLS I was able to determine the sales and leasing activity for the Greater Mission Bend Area. Below is the activity for October of 2009 as it compares to the same period in 2008.

- 51 homes sold which was 8 more than in October of 2008
- 16 of the 51 sold were foreclosures, 6 fewer F/C than in October of 2008.
- The median sales price for a nonforeclosure was \$56 per SF compared to \$62 per SF in 2008 but were on average 6 years older.
- In October 2009, the days on the market was 86 compared to 115 for the same period in 2008.

As of the end of November, 2009, there are 195 active sales listings, 10 of which are foreclosures

Rental Activity

27 homes leased in the month of October, which compares to the activity at this time a year ago. The rental rate remains at \$0.61 per square foot. As of the end of November, there were 54 active lease listings.

Houston Area Sales Activity vs. GMBA

The median price for homes sold in the greater Houston area in October 2009 was \$94 per SF compared to the \$56 per SF for the GMBA.

In October 2009, the days on the market for the Greater Houston area was 78 compared to 86 for the GMBA.



Collect Seeds and Save \$\$\$

Many plants produce seeds in the Fall. Some plants produce seeds after flowering at other times of the year.

Next spring, you may want to purchase bedding plants for front yard flower beds because it is an instant fix.

But, a pot of flowers grown from seeds collected from this year's flowers will be a nice addition to the back yard or even a nice gift for someone.

The Candle Stick Plant, pictured above, bloomed most of the summer and has now produced lots of seed pods.

Candle Stick Plants and many other small-tomedium sized trees/plants grow very fast. For additional information on this plant do an online search.

Pride of Barbados, Orchid Trees, Confederate Rose Trees and numerous other fast-growing seed producing trees/plants grow in our area.

There are many internet sites that give instructions on collecting and storing seeds; but, a general rule of thumb is to let the flowers or seed pods dry on the plant. You do need to watch them daily when they start drying because if you wait too long, the seeds will fall off or blow away.

There are several on-line seed/plant trading sites. I belong to one and have traded seeds from as far away as England. It is fun and a great way to save money on seeds and plants which, we all know, can be very expensive. Keep an eye on the neighbor's yards. They probably have plants going to seed and would be happy to have you collect a few seeds.
