The fire trucks were moved out of the service bay and seating was set up for a surprisingly large gathering of local citizens. If you were one of those in attendance, you got to hear Fort Bend County Judge Bob Hebert address the concerns of our community. You also got to hear representatives from various law enforcement agencies speak on the threat of crime in our neighborhoods. That was all well and good and was long overdue. There were a couple of very interesting events which followed this meeting.


Our goal is to get the Residents, Business Owners, Law Enforcement Officials and Local Elected Officials all working together to find better ways to fight the crime in our Community.

For one thing, we found out that the citizens of our community would stand up and speak out about the problems of gang activity and other criminal activity in this area. Who knew? Secondly, there was a redoubling of effort by local law enforcement agencies to bring an end to the driveway robberies. This happened very quickly as the perpetrators were caught shortly thereafter. I would say that the police agencies involved heard our concerns - and acted on them. Finally, and perhaps most importantly, a group of citizens came together in a quest to take the spirit of the community meeting to a new level. These concerned citizens began to meet and eventually became the founding members of the Greater Mission Bend Area Council. The rest, as they say, is history.

Well, three years have come and gone. Much time and energy have been expended in a quest to provide our collective neighborhoods an organization to address the many challenges we all face. The GMBAC has been successful in bringing awareness of our community to political leaders in both Harris and Fort Bend counties. We are hard at work defining problems and setting the stage for real solutions to the many challenges that face our community. And on June 26, 2010 we will host a special Town Hall meeting to celebrate our three-year history and to address our citizens' concerns about crime prevention.

Yes, crime is still a serious problem in this area. It is a problem in any area of the region. Unlike other areas in the unincorporated regions of Harris and Fort Bend counties, we now have an infrastructure to address the issue of crime. I think that I can say with all candor that crime is the first agenda item on the plate for the Greater Mission Bend Area Council. Just like three years ago, we want to invite all the citizens of this community to join us as we offer a second Town Hall meeting to address crime prevention. Our slate of speakers will be announced soon. I can tell you that the meeting will take place on June 26, 2010 beginning at 8:45 AM and lasting until 1 PM. The meeting will be held at Mission Bend United Methodist Church (www.mbumc.org) at 3710 Highway 6 South, across the West Park from Wal-Please check our web site at Mart. www.GMBAC.com as we post information and updates about the meeting. So, mark your calendars, come early and plan to stay late. We plan to have a program which will inform you and which will encourage you about the future of this area. I look forward to seeing you at the meeting.

Hurricane Season **Started June 1st**

HOUSTON (KTRK) -- Local officials have a message they want to stress to the public -prepare now for this hurricane season.

Houston Mayor Annise Parker and Harris County Judge Ed Emmett have four steps they want everyone to keep in mind as this hurricane season gets underway, from June 1 to November 30.

- Make a plan
- Build a kit
- Stay informed
- Know Your Neighbors

Local leaders boiled the priorities down to this list. They say prior to the immediate threat of a hurricane, you should know whether you live in a flood zone, how to evacuate if the need arises and how to contact friends and family if you get separated. For instance, you might need to have a back up copy of all those cell phone numbers you haven't memorized.

Officials add you should have enough food, water and first aid equipment to last at least three days and have at least a half tank of gas in your car at all times during hurricane season. They add that if you were living in the area during hurricanes Rita and Ike, it's a good idea to review your plans from years past, particularly following last year's very calm hurricane season.

Mayor Parker promised "The city will do its part, the county will do its part, the state of Texas will do its part, but each one of us who lives in a coastal region has to know what our role in that is.'

"We live in a hurricane-prone zone," Judge Emmett added. "We all hope and pray that we don't get hit, but if you operate under the assumption that a hurricane is going to come our way, then we're all much, much better prepared."

Judge Emmett also met with Galveston's mayor and said as soon as tropical force winds threaten the area, those coastal residents will be the first to evacuate. Anyone who needs special assistance including transportation, should call 211 now to be put on a list of those needing help in the event of an emergency. If you have called to be placed on this list before, you are asked to call again for this hurricane season.

Everyone is urged to get started on plans now, since this is anticipated to be a very busy hurricane season.

Are you still dealing with **Hurricane Ike problems?**

Payment Options Available for Delinquent Harris County Property Taxpayers

Avoid Additional Penalty

Because economic times are tough right now, the City of Houston would like to remind Houstonians who may be struggling to pay their 2009 real property taxes that were due January 31. 2010, that there are options. Prior to July 1, 2010, you can arrange to pay your taxes in monthly installments. In doing so, you can avoid the additional 20% collection penalty that will become due on July 1, 2010, if taxes remain

If there are no delinquent taxes from a prior tax vear, an installment agreement can be set up by contacting the Harris County Tax Office Call Center at 713-368-2000, or by going to your local Harris County branch office listed at http:// www.hctax.net/MiscTax/LocationsList.aspx. While the property owner will not avoid paying penalty and interest under the installment agreement, you will avoid the additional collection penalty of 20% on the outstanding balance by signing the installment agreement before July 1, 2010 and by making payments on time.

A new VA Clinic now open on U.S. 59

The outpatient clinic is located in the professional building near OakBend Medical Center, close to U.S. 59. The building is new and the clinic will be staffed by "highly qualified and experienced VA physicians, nurses, technicians, and administrative staff," according to a release from the Michael E. DeBakey VA Medical Center in Houston.

Beginning May 17, the clinic will be open from 8 a.m. to 4:30 p.m. Monday through Friday.

The clinic will provide primary health care, mental health care, laboratory and X-ray services to veterans in the Richmond-Rosenberg area. Emergency medication needs will be met on a local contract basis.

Veterans interested in transferring their care to the new Richmond VA Outpatient Clinic should speak with their current VA primary health care provider to ensure smooth transition of prescriptions and other medical information, the release said.

Small claims court is the real "People's Court." Small claims court provides a place where you can go to get back money that someone owes you. In small claims court, trials are informal. Most people who appear in small claims court do not have a lawyer. The purpose of small claims court is to provide an informal, uncomplicated proceeding to resolve small disputes which do not involve enough money to warrant the expense of formal litigation. There is only one major restriction in small claims court, the amount involved cannot exceed \$10,000.

1. Cucumbers contain most of the vitamins you need
